

Sub: Audit of accounts for the F.Y 2019-20

We have conducted the audit of books of accounts of Milagres College relating to the F.Y 2019-20.Our observations are as follows:

#### M.S.W/M.Com Account:

- 1. There is a sharp decrease in tuition fees collected in F.Y 2019-20 compared to the tuition fees of F.Y 2018-19 from M.S.W students. There is a sharp increase in fees from M.Com students. The fees reconciliation statement has not been provided to us.
- 2. A sum of Rs.1,58,244.00 has been received towards Synergy 2020 P.G fest. If contribution are received as sponsorship then the provisions of GST are attracted.
- 3. The collection for Golden Jubilee Fund is made in this account. This should not be done as the Golden Jubilee Fund is an independent trust.

#### College Account:

TDS has not been deducted on Audit fees paid. This matter was brought to the notice of account department during the interim audit.

#### Miscellaneous Account:

- 1. Tax has not been deducted at sources on payments amounting to Rs.5,341.00. The details have been given to the accounts department. Failure to deduct tax at sources will result in disallowance of 30% of the expenditure.
- 2. A sum of Rs.5,23,000.00 has been received towards Milagres Premier League . If contributions are received as sponsorship then the provisions of GST are attracted.
- 3. The salary of computer operator is partly paid from funds received from high school, PUC and church account. It is advisable for the high school, PUC and church to pay the amount directly to the computer operator rather than transferring the same to the miscellaneous account of the college. We have reduced the salary to the extent of the contribution from church, PUC and H.S. in the financial statements. /
- 4. The E.P.F and E.S.I is not paid on the salary paid to the computer operator and some other staff.
- 5. A sum of Rs.14,26,410.00 has been received as donation in cash towards UGC ground. Receipts
- have not been issued for the said donations and hence name and address of the donors are not

available for verification. If donations are not identified, the said donations will be considered as anonymous donations and will be liable for tax.

## P.O.E Account

An amount of Rs.1,66,000.00 has been paid to St. Joseph H.P.S. Before any payments are made to entities which are not units of the college or of CESU, we must be consulted in the matter as there are income tax implications.

## UGC Account:

1. During the year, UGC grant of Rs.34,18,101.00 has been received. However the grant spent is only Rs.14,88,470.00 .

2. A sum of 20,37,344.00 has been transferred to the miscellaneous account. However this amount has been shown as utilised and utilisation certificate has been submitted to the UGC.

Books of accounts are not been maintained for the said account.
