

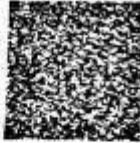



In accordance with the mutual desire to promote cooperation between Prithvi Institute of Management Education, Udupi (hereafter called the PRIME) and Milagres college Kallianpur (hereafter called the college), both the college and PRIME hereby enter into a formal statement of collaboration in the form of Memorandum of Understanding (MoU) for the purpose of academic interaction.

PRIME is established for the purpose of creating awareness among the young graduates about various employment opportunities in Central Government and State Government services and in Private Sector, and provide intensive training for the competitive examinations and interviews conducted by such recruitment bodies. PRIME conducts periodic short term training programmes for employment-seeking young graduates in campus recruitment training and communicative skills. It also conducts intensive training for the Civil Services Examinations (IAS) KAS, Banking exams and other competitive examinations

**MILAGRES COLLEGE – KALLIANPUR**

It was far sighted vision of the 83 year old Very Rev. Monsignor Denis Jerome D'souza which was instrumental in providing a college to rural students of Kallianpur. "The boys and girls who work in the field should be able to come to the college straight from the field" this was the mission of Mnsj.D.J.D'Souza the founder of the college.

This vision was realized in 1967 with the support of the parishioners of Milagres Church. Late Dr.P.G.Bhat, a great historian was the founder Principal of this institution. It was founded by the Catholic Board of Education of the Diocese of Mangalore with a view to provide collegiate education in this part of Udupi.

Now it is managed by Catholic Educational Society of Udupi (CESU), a managing committee with the Bishop of Udupi Diocese as the President. Currently the college offers courses leading to B.A., B.Sc., B.CA and B.Com, degrees at U.G level and M.Com, M.SW at P.G. level.

**Following are the terms of the Agreement :**

- 1. Prithvi Institute of Management Education, Udupi, will facilitate the following :**
  - The students of the college will be allowed to attend the training programmes conducted by PRIME for Banking examinations by enrolling themselves for such courses in advance.
  - Make available existing facilities like, library, classrooms, workshops, guest lectures, seminars etc.

- Make available the services of the faculty of PRIME for seminars, workshops and lectures conducted by the college in the area of Career Guidance, Personality Development Programme and Campus Recruitment Training etc., subject to the availability of the staff.
2. Milagres College will facilitate the following :
- The college will organize various programmes relating to career guidance and training for Banking examination in association with PRIME to help the students to get better employment opportunities.
  - The college will allow the eligible faculty to help PRIME in organizing the classes and training programmes at Kendra without disturbing their normal duties at their parent institution.
3. General
- PRIME will be in touch with the College regularly and provide information about the programmes conducted.
  - Nominal fees will be charged for all the training programmes organized by PRIME

This agreement will be in effect initially for a period of 1 year from the date of signing of this MoU by both the parties and renewed further if mutually agreed. Either party may terminate the agreement by written notification signed by the concerned official of the institution initiating the notice. Such notice must be served to the other party 6 months prior to the effective terminating date. However, obligations and commitments already contracted for and involving their parties shall be honored and continued by both parties until such commitments are completed.






